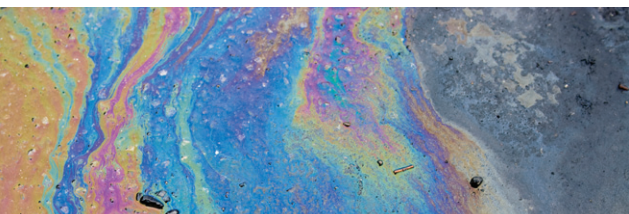


WHAT YOU AND YOUR CLIENTS SHOULD KNOW ABOUT THE BP SETTLEMENT PROGRAM
