DEAR COLLEAGUE:

This September the Forum will welcome you to Washington, D.C., for its 2013 Fall Meeting: Capital Projects: P3s, Design-Build, and Beyond. Section of Public Contract Law. Attendees can then choose between a workshop on the use of the P3 financing model for smaller projects and a workshop on the reality of green building and sustainability issues. The program's final plenary session on ethics will examine an array of issues and potential pitfalls arising from multi-jurisdictional and cross-border transactions.

Our program venue – the nation's capital – is familiar to many who know that Washington, D.C. never disappoints in terms of its magnificent monuments, memorials, museums and other attractions. Fall is a wonderful time to visit D.C. and we expect it to provide a unique and inspiring setting for our meeting.
