FINAL JUDGMENT

THIS CAUSE came before the Court on the claim of Plaintiff, TRINITY HIGHWAY PRODUCTS, LLC ("Trinity"), for attorneys' fees, paralegals' fees, costs and expenses, heard at evidentiary hearing on November 20, 2013, this Court having heard the testimony of all of the witnesses, having considered the documents which were entered into evidence, having considered the statutory and decisional authority provided by the parties, having reviewed the Court file, having heard argument of counsel, and being otherwise fully advised, it is hereby

ORDERED AND ADJUDGED THAT:

- 1. This Court entered its Order Granting Trinity's Motion for Attorneys' Fees and Costs on January 14, 2014, which granted the Trinity's Motion for Attorney's Fees, Costs and Expenses dated July 19, 2013. Said Order is incorporated herein by reference.
- 2. Said Order allowed Defendants, TRAVELERS CASUALTY AND SURETY COMPANY OF AMERICA ("Travelers") and DESIGN BUILD ENGINEERS & CONTRACTORS, CORP. ("DBE&C") (collectively, the "Defendants"), jointly and severally,

fifteen days to pay the amount of \$989,671.89 to Trinity, failing which, this Court would enter Judgment.

- 3. Travelers and DBE&C have failed to pay Trinity the amount of \$989,671.89 within fifteen days of said Order.
- 4. Trinity shall recover from Travelers and DBE&C, jointly and severally, the total Final Judgment amount of Nine Hundred Eighty-Nine Thousand Six Hundred Seventy-One and 89/100 Dollars (\$989,671.89), for which let multiple writs of execution issue instanter.
- 5. The total amount of this Final Judgment set forth in Paragraph 4 hereinabove shall bear post-judgment interest from the date of this judgment until paid at the legal rate of four and three-fourths percent (4.75%) per annum.
- 6. The address of Trinity is: 2525 North Stemmons Freeway, Dallas, Texas 75207. The address of Travelers is: Bond and Financial Products Claims, One Tower Square S102A, Hartford, Connecticut 06183. The address of DBE&C is: 5200 Vineland Road, Suite 250, Orlando, Florida 32811.

It is further ordered and adjudged that said Defendants, as the Final Judgment debtors, shall complete under oath Florida Rule of Civil Procedure Form 1.977(b) (Fact Information Sheet), including all required attachments, and serve them on the Final Judgment creditor's attorney within forty-five (45) days from the date of this Final Judgment, unless the Final Judgment is satisfied or post-Judgment discovery is stayed.
- 8. Jurisdiction of this case is retained to enter further Orders that are proper to compel the Final Judgment debtors to complete Form 1.977(b), including all required attachments, and serve them on the Final Judgment creditor's attorney.
 - 9. This Court reserves jurisdiction of this action to enter all other appropriate orders
