## **COVID UPDATES**

#### **Attendee Health Attestation**

To do our part in preventing the spread of COVID-19, we are restricting attendance at any of our Executive Council meetings from anyone with knowledge that they have a COVID-19 Infection or have recently been exposed to the virus.

- (c) You have not in the last 14 days traveled from (1) areas of substantial community spreading requiring quarantine per the Florida Department of Health, or (2) traveled internationally based on the current US State Department Level 4 travel advisory for all international travel due to the global impact of COVID-19.

If you cannot affirm or attest to any of the above on the day of the event, please do not attend. We will gladly provide you with a full refund. There is a risk of COVID-19 exposure in any public place where people are present. COVID-19 is highly contagious and can lead to illness and death. By attending the event, you voluntarily assume all risks related to COVID-19 exposure. Thank you for your cooperation.
