B. Louis Guttman – Request for vacation rentals. The Legislation sub-committee was asked to review HB 307, which deals with the regulation of public lodging establishments and public food service establishments. The Sub-committee reviewed the House Bill and offered the conclusion that the proposed statute is not within the purview of the Landlord Tenant Committee and therefore had no comment.
