1. Welcome and Introductions

- 2. Chair, Brenda Ezell, sought Approval of the Minutes from the March 15, 2019 meeting, at the Omni Hotel, Amelia Island, Florida. Phyllis Harley moved to approve the Minutes and Arlene Udick seconded the motion. The Minutes were approved unanimously.
