RPPTL SECTION REAL ESTATE LEASING MEETING Minutes of Meeting on November 4, 2021 Hybrid Meeting - The Luminary Hotel, Ft. Myers, FL

- 1. Meeting Called to order- The meeting was called to order by Brenda Ezell. Brenda Ezell turned the meeting over to Chris Sajdera, Co-chair of the Real Estate Leasing Committee, to lead the meeting at approximately 2:03 p.m.
- 2. Introduction of Committee Sponsor: Melissa Scaletta from Attorneys' Title Fund Services, LLC, was introduced and she explained the services available to the members of the committee.
- 3. Chris Sajdera moved to approve the meeting minutes for the Breakers July 12, 2021 meeting. Chip Waller stated if no objections, the minutes stand approved as read.
- 4. Terrance Harvey, technology liaison, provided and update for the committee.
- 5. Brenda Ezell provided an update on the recording and scheduling of the Advanced Leasing Symposium to be scheduled for early 2022. The seminar will be an eight-hour CLE.
- 6. Amanda Kison, newly appointed legislative liaison, provided a legislative update reviewing three bills, including:
 - a. SB582 seeking to amend 83.60(2)
 - b. SB512 seeking to amend 212.03, 509.013 and 509.032
 - c. SB580 seeking to amend 125.0103 and 166.043
- 7. Brenda Ezell provided an update on the Service of Process of Unknown Parties in Possession. The proposed bill has a potential sponsor and has been added to additional proposed legislation. The proposed legislation received edits back from Tallahassee bill drafting. The proposed changes were mostly non-substantive with the expedition of reducing the number of attempts to serve from three to two and reducing the time in between service attempts to six hours. Willie Kightlinger joined Brenda in providing the update to get feedback on the proposed changes from bill drafting. Chip Waller provided comment in support of the changes received by the bill drafting. No other comments were made in response to the changes.
- 8. Missy Davenport joined our meeting to provide an update on the FACE program. Missy reported that 23 volunteers have signed up to assist in the Northeast Florida region.

- 9. Kris Fernandez presented on current eviction issues, including an update on the proposed requirement that landlord/tenants attend a mandatory mediation in eviction cases. Amanda Kison provided an update on the status of the proposed mandatory mediation requirement. Kevin Rabin provided comments in support of the mandatory mediation in eviction cases, comparing the proceedings to small claims action that have a mandatory mediation requirement. Salome Zikakis and Amanda Kison responded to Kevin Rabin's position.
- 10. Chip Waller discussed two issues that were addressed in problems study, including the postal service no longer providing return receipts on certified mail and the need to update statutes that specifically require return receipts. The second issue Chip Waller provided an update on is legislative matter proposed by the business law section that allows liens to be placed on mobile homes. Willie Kightlinger added to Chip's presentation to state that a subcommittee within the section has reviewed the bill and that a full presentation of the bill will be made at Problems Study.
- 11. Kristen King Jaiven provided an update on the Miami-Dade County Landlord Bill of Rights Project and sought volunteers to work on a subcommittee to address the Miami-Dade County project and a landlord tenant bill of rights generally. Michelle Hinden; Kris Fernandez; Kevin Rabin; Amanda Kison; Brenda Ezell; Chris Sajdera; and Missy Davenport volunteered for the subcommittee.
