Civil Papers:

Arrests:

- On 02/28/2005 at about 20:30, a 23 year old Minnesota man was arrested for excessive DUI and for Driving Without Privileges (DWP) after a citizen reported his unusual and dangerous driving patterns near the landfill on Highway 8. He became argumentative with the arresting deputy and jail deputies were called to assist when the man was brought into the jail.
- On 3/1/2005 at about 14:45, 55 year old commercial truck driver from Spokane was cited for Inattentive Driving (a misdemeanor) after striking a Moscow Police Department vehicle near Northwest River Supply in Moscow. No one was injured in the collision.
- On 3/2/2005 at about 19:20, a 35 year old Lewiston man, Donald W. Mosley Jr., was arrested for DWP on Highway 95 at about milepost 331. On 3/9/2005, a warrant was issued for Mosley's arrest for Failure to Appear on the DWP charges. He has not been apprehended as of the date of this post (3/14/2005).

- On 3/3/2005 at about 20:00, a 28 year old Boise man was arrested for DWP during a traffic stop at the intersection of 6th and Hayes Streets in Moscow.
- On 3/5/2005 at about 23:19, two 19 year old Post Falls women were cited for Minor In Possession of Alcohol (MIP) during a traffic stop in Moscow.
- On 3/5/2005 at about 22:45, a 33 year old Moscow man was arrested for DUI on 6th Street in Moscow.
- On 3/5/2005 at 23:55, a 26 year old Moscow man was arrested for DWP on Lenville Road.
- On 3/5/2005 at 01:53, after eluding officers in a car pursuit in Potlatch, an 18 year old Potlatch man was arrested for DUI and was cited for misdemeanor Injury to a Child, Possession of Marijuana and Possession of Paraphernalia. At the same time, deputies cited a 16 year old male juvenile for Minor In Consumption of Alcohol (MIC). The 18 year old man was the driver of a 4-wheeler and the 16 year old was riding behind the 18 year old on the back of the 4-wheeler. The 16 year-old was not wearing a helmet.
- On 3/6/2005 at 01:45, a 37 year old Coeur d'Alene man was cited for DWP on the Pullman Road in Moscow.

Even though the weather appears nice, winds or air currents can send a controlled burn into unintended areas. Have proper tools available to extinguish fires and be sure to call 911 as soon as your fire blazes beyond your control.
