Civil Papers:

Arrests/Calls:

- On 03/11/2005 at about 08:43, a 16 year old Kendrick male was cited for a school bus violation, a misdemeanor citation.
- On 3/11/2005 at about 19:43, a 14 year old Juliaetta male was arrested for Aggravated Assault, a Felony, at his home in Juliaetta after threatening family members with both a knife and an arrow
- On 3/12/2005 at about 02:15, Elias Russell was arrested pursuant to a detention order. Russell was at a friend's house in Potlatch, Idaho. After being released to his family and being placed on electronic monitoring on 3/17/2005, Russell cut his electronic monitoring bracelet and absconded. He is still at large and there has been another detention order signed for his detainment.
- On 3/14/2005 at about 19:17, a 41 year old Potlatch man was cited for Driving Without Privileges at milepost 349 on Highway 95.
- On 03/14/2005 at about 02:19, an 18 year old Moscow man was arrested for an under-age DUI. The man admitted to driving a vehicle that deputies found in a field off Mountain View Road. The man was arrested for DUI. Later in the morning, deputies contacted another male, a 20 year old Moscow man, who was the owner of the vehicle deputies had found in the field. The 20 year old was arrested for Minor in Consumption.

Elias Russell: Latah County Deputies are again looking for Elias Rus-

sell. Russell ran away from his home in Potlatch on January 31, 2005. He was found and detained on March 12, 2005, but escaped electronic monitoring on March 17, 2005. Although there are rumors that Russell ran away to avoid physical abuse, deputies and agents from Health and Welfare have never been able to sustain any claims. Additionally, in the most recent interview with Russell, he told authorities that he was not being physically abused by either of his parents. Although no charges have yet been filed against people harboring Russell or concealing material information from authorities during his flight, deputies are actively investigating the case.
