Safety Tip: Harassment

If you believe that you are being harassed over the phone, start keeping a log of incoming calls that you believe to be harassing or threatening in nature. In that log include the following information:

- Time of call
- Name and phone number of caller (if you know)
- Duration of call and how it was terminated (you hung up or they hung up)
- Content of the call including specific language used and/or threats made

If someone calls and harasses you, make sure you clearly tell them not to call you again for any reason. Report telephone harassment to both your local law enforcement agency and to your telephone company.
