Civil Papers:

Arrests:

- On 05/03/2005, at 09:16, an 18 year old Juliaetta man was issued a misdemeanor citation for failing to stop for a school bus while it was loading. This offense occurred in Juliaetta.
- On 05/04/2005, at 19:08, deputies responded to a vehicle fire near Kendrick. When they arrived, they found that the passenger, a 20 year old Yakima man, was intoxicated, Deputies arrested the man for MIC.
- On 05/05/2005, at 07:29, a 20 year old Moscow man was cited for DWP after a traffic stop on Highway 95 at Thorn Creek Road.
- On 05/06/2005, at about 14:48, deputies responded to the 1600 block of Carmichael Road after receiving information about suspected drug activity. When they arrived, deputies saw drug paraphernalia in the home. They secured a search warrant and later seized both drug paraphernalia and illegal drugs. Two were cited for possession during the incident: an 18 year old Viola woman and an 18 year old Pullman man. Kilo, LCSO's drug dog, had assisted in the service of the warrant.
- On 05/07/2005, at 23:26, a 28 year old Pullman man was arrested for DUI after a traffic stop on Highway 8 at Mill Road.
- On 05/07/2005, at 07:24, a 17 year old Troy juvenile was cited for MIC/MIP after his/her vehicle slid off the road near Deary. The juvenile had an opened bottle of alcohol in the vehicle at the time of the slide-off.
- On 05/07/2005, at 13:13, a woman reported having seen someone "prowling cars" on Sand road. Later, a 34 year old man was cited for unlawful entry in connection with the call. At the time he was cited, he was incarcerated in the Latah County Jail on other related charges.

Crime Facts

Shows like *CSI*, *NCIS*, and *Law & Order* are fun to watch and also sometimes contain real and valuable information or lessons. However, *real* police and *real* crimes are not like those seen on TV. Deputies are often asked why they haven't run fingerprints through the computer to find the suspect. The truth is, we do not have a database where we can simply "run" a print. When we do find fingerprints at a crime scene, we send them into the State Lab for comparison. Most prints return to us as "unknown" or "insufficient ridge detail." It usually takes several weeks to several months to even get those returns! Additionally, there are a lot of surfaces that cannot be fingerprinted. If a deputy tells you he/she doesn't see prints on a surface or that it is a surface that is too porous to print, believe it. We wish it was easy as it seems on TV, too, but until then, we'll keep trying "the old fashion way."
