Idaho Redistricting Fast Facts

Redistricting 101

- Redistricting is the process to align the state's political boundaries to match population changes to ensure every voice has a vote. Redistricting is done every 10 years, after the state receives the most recent population results from our nation wide federal census.
- Since 2000, Idaho has grown by 250,000 people. That's the equivalent of an additional Boise and Pocatello. Ada and Canyon counties have seen most of the growth in Idaho, with our rural areas actually losing population.
- These newly created districts will ultimately shape the political face of Idaho for the next 10 years and guide decision-making on important issues such as education and public schools, health care and reproductive rights, jobs and the economy, and technology and the environment.
- The Bipartisan Commission on Reapportionment has been charged with the task of redrawing Idaho's district lines. The Commission is made up of 3 republicans and 3 democrats, none of which can be active politicians or current lobbyists. The Commission answers only to the Idaho Supreme Court.

Redistricting Guidelines

- The goals are to make districts with equal population size, keep politics competitive, and create boundaries that make sense and don't split up communities. To that end, the Commission has several guidelines they must follow:
 - o Legislative districts should not differ in population by more than ten percent.
 - o The creation of oddly-shaped districts to string together voters of a particular race (or gerrymandering), for any reason, is disfavored under Idaho law.
 - o Legislative districts should maintain local voting precinct boundaries, should preserve communities of interest and traditional neighborhoods, and should avoid dividing counties. If a county division is necessary, the counties being melded must be contiguous and connected by a highway.
 - o District lines should not be made to favor or protect an incumbent or party.

Progress on Redistricting

- After hosting 14 public hearings to glean public input, the commission has unanimously
 agreed to keep all 35 legislative districts to retain as much voter representation in the
 legislature as possible.

- In a bi-partisan resolution, the Latah County Board of Commissioners showed their unanimous support for a Latah-Benewah District on August 10, 2011.

LTE & Email "How To"

Basics for writing your email of Letter to the Editor (LTE)

- 1. State why this issue is relevant to our community.
- 2. State why this issues matters to you—make it personal.
- 3. State why the reader or community should care about this issue.
- 4. Fill out your letter with related stats, anecdotes, and stories.

NOTE: Feel free to use the "Fast Facts" about redistricting, but we ask that you put them in your own words and mix up the order, so messages don't sound canned. The following points are the most important for the commissioners and public to hear:

- Respect communities of interest so that everyone has a voice.
- Keep counties whole, to the extent possible—as called for in the state Constitution.
- Keep cities (as communities of interest) intact, to the extent possible.
- One person, one vote. It's the American way and it's the Idaho way.
- Respect and uphold the Idaho Constitution.
- Serve the people, don't stack the deck.
- Voters should pick their politicians; politicians shouldn't pick their voters.
- These newly created districts will shape the face of Idaho for the next 10 years.
- Create boundaries that make sense and don't split up communities!
- Every Idahoan deserves a voice in determining our state's future!

Helpful "Dos" and "Don'ts" for emails to the commission and letters to the editor:

DO:

- State where you live and what type of work you do (teacher, parent, construction worker, etc)
- If you've lived in Idaho a long time, say so
- Talk about the fundamental values: fairness, transparency
- Keep it simple, brief and clear—for LTEs, assume your audience is completely uninformed
- Evoke Idaho pride
- Talk about everyone deserving a voice and a vote
- Be positive
- Thank the Commissioners for their work and their service to Idaho
- Thank the Commission for the opportunity to comment (email)

DON'T:

- Fall into jargon or get bogged down in details
- Be partisan or bring Party politics into it—the issues Idahoan's care about transcends mere politics
- Preach gloom and doom
