14 **PLEASE TAKE NOTICE**

15 1. I filed the attached *Declaration of Completion of Probate* with the above
16 Court on _____, 20**.

17 2. Unless you file a *Petition* with that Court requesting it to determine the
18 reasonableness of the proposed fees, or for an estate accounting, or both, and serve a
19 copy of your *Petition* on me within thirty (30) days after the date of filing of the
20 *Declaration of Completion of Probate*:

- 21 a. The schedule of fees paid or to be paid as set forth in the *Declaration of*
22 *Completion of Probate* will forever be considered reasonable;
- 23 b. My acts as Personal Representative performed before the *Declaration of*
24 *Completion of Probate* was filed will forever be considered approved, and I
25 will be automatically discharged without further order of Court with respect to
all such acts; and

1 c. The *Declaration of Completion of Probate* will become final and forever be
2 considered for all legal intents and purposes as the equivalent of a *Decree of*
3 *Distribution* entered under the probate law of the State of Washington
4 (specifically, RCW 11.76).

5 3. I will retain the power to deal with the taxing authorities, together with a
6 cash reserve of \$___ for the determination and payment of all remaining tax
7 obligations and reasonable expenses. Only that portion of the reserve that remains
8 after the settlement of any tax liability, and the payment of any expenses associated
9 with such settlement, will be distributed to the persons legally entitled to the reserve.

10 4. If you file such a *Petition* with the Court and serve a copy of it on me
11 within the period specified, I will request the Court to fix a time and place to hear your
12 *Petition*, and you will be notified of that time and place by mail or personal service not
13 less than ten (10) days before the hearing on your *Petition*.
