We made a decision about your unemployment benefits claim based on information we have at this time.

**We denied your unemployment benefits starting Dec 27 2020 until the reason for our decision no longer exists.**

Under the Continued Assistance Act, you must send us documents about your work history to qualify for Pandemic Unemployment Assistance (PUA).

We asked you for your information, but you did not respond.

Without more information, we presume you don't have an adequate work history to qualify for PUA. Any benefits you received for the weeks ending Jan 2 2021 and later are now denied and you will need to repay them.

The law that applies is Public Law 116-260 Section 241.

This decision affects your Pandemic Unemployment Assistance claim, and these additional laws apply: Public Law 116-136 section 2102

If we need to consider other questions about your claim, we'll send you separate letters to address each issue.
